



## **KWANTLEN POLYTECHNIC UNIVERSITY – GET READY, GET HIRED CONTEST Official Contest Rules and Regulations**

Participation in the Get Ready, Get Hired Contest (the "Contest") constitutes the entrant's full and unconditional agreement with and acceptance of these Official Contest Rules and Regulations ("Official Rules") and all decisions of Kwantlen Polytechnic University ("KPU" or the "Sponsor") and its agents, which are final on all matters relating to the Contest.

Entrants must be a current KPU student or KPU alumni, aged 16 or older, and resident of BC. Faculty and staff of KPU are not eligible. All provincial, municipal and federal laws and regulations apply.

### **3. WINNER SELECTION**
