

KWANTLEN POLYTECHNIC UNIVERSITY – SURREY OPEN HOUSE 2017 TUITION CONTEST Official Contest Rules and Regulations

Participation in the Surrey Open House 2017 Tuition Contest (the "Contest") constitutes the entrant's full and unconditional agreement with and acceptance of these Official Contest Rules and Regulations ("Official Rules") and all decisions of Kwantlen Polytechnic University ("KPU" or the "Sponsor") and its agents, which are final on all matters relating to the Contest.

1. ELIGIBILITY

Entrants must be aged 16 or older, and resident of BC. Faculty, staff, and current KPU students are not eligible. All provincial, municipal and federal laws and regulations apply.

2. HOW TO ENTER

To enter, entrants must attend the KPU Surrey Open House on Saturday, March 4, 2017 and complete the tuition waiver entry form and return it to the main registration booth, Main Building, KPU Surrey, 12666 72 Avenue, during the Contest Period (as defined below) to receive one (1) entry into the Contest (each an "Entry"). Maximum one (1) Entry per person.

No purchase is necessary in connection with the Contest.

3. WINNER SELECTION

Three (3) entries will be randomly drawn from all eligible available entries at the Future Students' Office, Room C104, Main Building, KPU Surrey, 12666 72 Avenue, Surrey at 12:00pm PST on Monday, March 6, 2017 (the "Contest Draw").

Odds of winning depend on the number of eligible entries received.

4. PRIZE CLAIM CONDITIONS

The individuals named on the Entry(ies) drawn pursuant to the Contest Draw (each a "selected entrant") will be notified by the email address and phone number provided on the entry form on Monday, March 6, 2017 at 12:00pm PST.

In order to claim his/her Prize the selected entrant must present his or herself, with valid photo identification at the Future Students' Office, Room C104, Main Building, KPU Surrey, 12666 72 Avenue on or before 4:00pm PST on Monday, March 20, 2017. Before being declared a "Winner" and being awarded the Prize, the Winner must first correctly answer without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question to be administered at the time the selected individual presents his/herself at the Future Students' Office, Room C104, Main Building, KPU Surrey, 12666 72 Avenue, Surrey. The Winners will also be required to complete a written declaration and prize release form, releasing the Sponsor and all of their respective directors, officers, owners, partners, shareholders, employees, agents, representatives, successors and assigns from any liability in connection with the Contest or the use or misuse or possession of any Prize. Return of winner notification as undeliverable, inability to reach the selected entrant, failure to claim a Prize within the required time period, failure to provide proof of eligibility, release documents, or other required documentation (if requested) in a timely manner, failure to correctly answer the skill-testing question, or other non-compliance with these Official Rules may result in disqualification, forfeiture of the Prize and, at Sponsor's sole discretion, selection of an alternate selected entrant for the forfeited Prize, who will be subject to disqualification in the same manner.

To redeem the tuition waiver, winners must contact the Future Students' Office at KPU with the waiver they receive. Arrangements will then be made to credit their KPU student account.

5. DEADLINES

Contest begins on Saturday, March 4, 2017 at 11:00am PST and ends on Saturday, March 4, 2017 at 3:00pm PST (the "Contest Period").

6. PRIZING

There are three (3) prizes to be awarded in connection with the Contest. Subject to the Prize Claim Conditions outlined above, the selected entrant(s) will be awarded one of the following prizes (each, a "Prize"):

3x \$500 KPU Tuition Waiver, total approximate value of all prizes, \$1,500

Prizes must be accepted as awarded.

No cash substitutions. Each Prize (the tuition waiver) is non-transferable must be redeemed before the Summer 2019 semester. Waivers expire on March 4, 2019.

7. PERSONAL INFORMATION

KPU and its authorized agents will collect, use and disclose the personal information you provide when you enter the Contest for the purposes of administering the Contest and Prize fulfillment. Such personal information is collected under the authority of and will be protected, used and disclosed in compliance with British Columbia's Freedom of Information and Protection of Privacy Act.

By entering the Contest and accepting a Prize pursuant to the Prize Claim Conditions above, the Winners authorize Kwantlen Polytechnic University and its advertising and promotional agencies and their respective employees or other representatives, to broadcast, publish and otherwise use the Winners' name, photograph, image, statements regarding the Contest and/or the Prizes, and (or) voice for publicity purposes relating to the Contest, without any form of remuneration, approval or further notice.

8. RELEASE

By entering this Contest, you agree to indemnify, release and hold harmless, Kwantlen Polytechnic University, its employees and its agents from and against any losses, damages, rights, claim or cause of action of any kind arising, in whole or in part, directly or indirectly, out of your breach of the Official Rules, the use of your Entry in the manner set forth in these Official Rules, use of the Prize or otherwise resulting from your participating in the Contest.

9. MISCELLANEOUS

Kwantlen Polytechnic University reserves the right, in its sole discretion, to cancel or modify the Contest if fraud, technical failures, or anyone's actions destroys the integrity of the Contest, or if factors beyond the Sponsor's control make it impossible for the Sponsor to administer this Contest as planned. Entrants who have not complied with these Official Rules are subject to disqualification. The Prizes are not transferable and must be accepted as awarded with no substitutions in cash or otherwise, except at Sponsor's sole discretion. Sponsor reserves the right to substitute an alternate prize of equivalent or greater value if a Prize cannot be awarded as described. The Prizes will only awarded pursuant to the Prize Claim Conditions outlined above. By entering this Contest, you agree to be bound by these Official Rules and the decisions of the Sponsor. All decisions of the Sponsor and/or Committee are final and binding in all matters relating to this Contest.
