Research Involving Human Participants Policy

CONTEXT AND PURPOSE

The purpose of this Policy is to promote ethical research practices, protect the interests of human participants, and describe institutional standards and procedures governing research involving human participants in compliance with the Tri-Council Policy Statement: Ethical Conduct of Research Involving Humans (second edition -2010, referenced herein as the “Tri-Council Policy Statement” or “TCPS”)¹.

SCOPE AND LIMITS

This Policy applies to all research involving human participants conducted under the auspices of Kwantlen Polytechnic University (“Kwantlen”). Research conducted under the auspices of Kwantlen includes, but is not limited to, research where funds are provided through or administered by Kwantlen; research where the researcher’s affiliation with Kwantlen is explicit in contracts, reports or publications; research which utilizes Kwantlen resources (including accountable and professional development time); and research conducted by Kwantlen students as a component of their course or program requirements.

Unless expressly exempted, all research involving human participants requires prior approval by the Research Ethics Board, either by full or delegated review, as outlined in subsequent sections of this Policy.

STATEMENT OF POLICY PRINCIPLES
