#### **Update on Meta Evaluation** / David Ross

The External Audit Report is now available. Kwantlen has begun implementation of several recommendations. Other recommendations will become part of the budget process. Copies of the Meta Evaluation Report and the External Audit Report will be made available in all four libraries.

#### **Budget Update** / David Ross

At present, the shortfall is \$9.9 million for the 2002/2003 budget.

The 2001/2002 operating budget is on target. Mr. Ross suggested that severance payments be included in the year that the decision is made.

**Update on Kwantlen's Relationship with the School Districts** / Judith McGillivray Kwantlen's relationship with the school districts will be included in the strategic plan being developed. As well, the high school liaison officer will be involved in developing the relationship with the school districts. Ms. McGillivray will continue to pursue articulation agreements with the various school districts.

Kwantlen is planning to formalize a report on how students from the various high schools in our region fare when they are at Kwantlen. The school districts have requested this information.
