• Formation of Audit Review Committee

The Vice President Administration advised that he has received a suggestion from the Auditor General's office that the Board consider forming a sub-committee to meet with the auditors. The Board agreed that, as it operates within the Policy Model of Governance, it will continue to address Board issues as a whole.

• Human Resources Report

As an addition to the Human Resources Report, the Executive Director of Human Resources advised that the Provincial Support Staff negotiations will be meeting on the 7th of April to discuss protocol.

• Building Renovations

The Vice President Administration advised that the tenders for building renovations closed on 2nd March with five bids received. The successful bidder is Swagger Construction. This is the same organization that is currently working on the new construction. Renovations are scheduled for completion 15th August 1999.
