• Capilano College Audit Report

The Vice President Administration reviewed the Office of the Comptroller General Audit Report on Capilano College dated May 1995. It was suggested that Kwantlen University College external auditors be requested to comment on the report and the controls in place at the University College. The external auditors will be invited to attend the 28 June Board Meeting.

• Facilities Monitoring Report / Richmond Lecture Hall

The Vice President Administration advised that tenders for the construction of the Richmond Lecture Hall were advertised and will close 30 May 1995. The project schedule estimates completion in early January 1996.

• Proposed Horticulture Practical Training & Testing Centre

North Surrey Community Skills Centre

• The President advised that a submission requesting a Community Skills Centre in North Surrey has been forwarded to the Ministry.

Kekinow Cultural and Educational Society

• The President advised that the Kekinow Society and Kwantlen University College will be working together to develop funding proposals for submission to the Ministry.

Enrolment / Summer Semester

For Summer 1995, the University College initially offered 64 sections at the Langley, Richmond and Surrey campuses, a total of 2,223 seats. Subjects offered include Accounting, Business, Computer Based Systems, Computer Information Systems, Economics, Marketing, Fine Arts, Philosophy, Anthropology, Criminology, Geography, History, Psychology, Sociology, Chemistry and English. 1,060 students have enrolled in 1,803 seats. Seven sections were cancelled due to low enrolmnet. Capacity utilization is 86.98% excluding the cancelled sections.
