### Surrey Community Resource Society

The Board requested the President to advise the Society that while there is strong support for the mission and role of the Surrey Community Resource Society, the Board felt that it was not in a position to offer an opinion with respect to the construction of a 12-Unit Apartment Complex in North Surrey. There is no doubt that there is a need to expand services to meet the demands of a growing and diverse population. However, support for something as specific as identified is beyond both the mandate and role of Kwantlen's Board of Governors.

# President's Report

- The Vice President Education/Academic & Applied Studies advised the Board that 64 courses were offered at Summer School / 46 courses were conducted (this number exceeded last year); for a total of 135 FTEs.
- The Vice President Educational & Organizational Support advised the Board that TeleReg concluded 24 August / late registration will take place between 06 and 19 September. Advertisements will be carried in the papers early next week advising of available seats.
- The Vice President Educational & Organization Support advised that the Central Application System (PASBC) implementation is scheduled for September 1996 intake. The Vice President is a member of the Advisory Council.
- ★ The Acting Vice President Education/Applied Arts & Career Preparation reviewed the signing ceremony that took place between the College and Mercury Marine; the working relationship is scheduled to commence in October. Four MLAs were in attendance.
- The Vice President Administration reviewed a recent meeting held with the Ministry regarding Cloverdale and Surrey Phase II Planning Process.
- The President advised that a special event is being planned for the official opening of the Pedestrian Overpass at the Langley Campus. A major event to recognize the announcement of Cloverdale is being developed.
