Call to Order The Chair called the Meeting to order at 6:00 pm; introduced David Ross, Executive

Director Marketing & Development and welcomed the guests. Mark Stephens, President Student Association distributed the new Student Daytimers and pens to the Board Members.

Presentations English Pre-requisites

The Vice President Education gave a background overview and presented the Task Force results and recommendations as requested by the Board of Governors at the June 1999

meeting.

In 1997/1998, members of the English Department noted concern regarding student success in university transfer English courses. In particular, significant numbers of students were withdrawing or failing and classroom tensions often reflected this.

In the Spring of 1998, the English faculty began to gather information to help shed more light on their anecdotal evidence. As a result of this work, in November/December 1998,

the English department proposed to their Divisional Curriculum Committee and, upon receiving support, proposed to the Education Council that there be a change in the entrance requirement to the University Transfer English Courses 1100 and 1110 from and English 12 grade of "C" or higher to and English 12 grade of "B" or higher or an assessment through an entry or placement test.

As well, it was proposed to change the entrance requirement to developmental English 0099 from and English 12 grade of "P" or "C-" to an English 12 grade of "C" or higher or assessment through an entry or placement test.

In December 1998, the Education Council approved this proposal. In January 1999, the Board of Governors delayed approval of the proposed change pending further information. The Education Council requested the Intake & Assessment Committee to provide the background material for the June 1999 Board Meeting.

In June, the Board requested additional information to help in their consideration of the proposal for discussion at the August Meeting of the Board of Governors.

English Prerequisites

Subsequent to the English Pre-requisites presentation and discussion, the following motion was put forward:

Moved by Navnit Shah; Seconded by Tim Glatley:

THAT the Board of Governors approve the English Grade 12 pre-requisite for entry to English 0099 be increased to a "C" Grade; and

THAT the English Grade 12 pre-requisite for entry to English 1100 and 1110 be increased to a "B" Grade; and

THAT the Board of Governors endorse the Task Force recommendations as follows:

- the entrance requirements be effective September 2000;
- the Secondary Schools be notified immediately so that 1999/2000 Grade 12 students are aware of the changes;
- there is availability for students without the required pre-requisites to be assessed through an entry or placement test;
- clean educational pathways related to development of English language competencies be developed and additional sections of developmental English courses be added to provide increased opportunities for students who do not meet the altered entrance requirements.

President's Report

• Resolution "100% Purchase of Pensionable Service by an Employee"

Moved by Janet Shauntz; Seconded by Navnit Shah:

THAT upon application by a current Kwantlen employee who is a member of the Municipal Pension Plan, Kwantlen recognizes as pensionable service under the Pension (Municipal) Act all or part of the service an employee for any employer, whether or not the employer is an employer to whom the Act applies, provided that the employee pays 100% of the additional sums specified by the Superannuation Commission. Any exceptions to this must be approved by the Board of Governors.

• Cloverdale Update

The Vice President Administration advised the Board that an "Expression of Interest" regarding pre-servicing of the site has been forwarded to the City of Surrey. A request has been forwarded to the Ministry for funding to re-zone and prepare documentation for pre-servicing (pending selection by the City of Surrey). The Ministry of Advanced Education and the Ministry of Finance have requested a "Memorandum of Understanding describing the development process; a draft has been forwarded to both Ministries. Discussions will continue in September.

• President's Update

The President commented as follows:

- a two-day Senior Leadership Team Planning Session is scheduled for the 7th & 8th of September at Coyote Creek;
- advised the Board of the Senior Leadership Team organizational changes;
- two new "named" scholarships through pledges to endowment funds have been created. The benefactors are the North Delta Rotary Club with a pledge of \$10,000 and the Tsawwassen Rotary Club with a pledge of \$5,000. When supplemented with provincial matching funds, these will, after one year of endowment investment, support student awards of \$1,000 and \$500 respectively, every year in perpetuity.
- Mrs. Margaret Westerman has graciously donated an additional \$10,00 to the

"Ernest Westerman Memorial Fund". There has previously been two awards of \$1,000 each generated from this fund; there will now be three awards of \$1,000 given to the most deserving students with preference to graduates of Surrey Schools who demonstrate financial need and academic achievement. This donation is also eligible for the provincial matching funds.

"Emeritus" Designation

Moved by Navnit Shah; Seconded by June Laitar:

THAT the designation "Emeritus" be approved as follows:

The designation of "Emeritus" is an honorary appointment awarded to a retired Kwantlen employee for service and commitment to the University College for a minimum period of ten years before retirement and establishes a symbolic relationship between the individual and the institution. The applicant should have demonstrated commitment to the appropriate faculty, school or department as well as to the institution. The emeritus appointment will allow the continuation of that commitment past retirement. Emeritus appointments are for life.

The appointees will

- be eligible to apply for grants from external agencies through the established University College routes of approval. Collaborative applications between the emeritus appointee and members of the department are encouraged.
- have access to library, secretarial, technical, and computing services consistent with Kwantlen's activities and policies, resources permitting.
- be eligible to accept assignments/contracts for special projects beneficial to the University College.
- be entitled to represent the University College at social/fund raising events.
- be invited to all Kwantlen events and receive recognition for contributions to the University College.
- be recognized at the Annual Employee Recognition Ceremony, which normally takes place in April.

Appointment Procedures:

- application should be made to the Tributes Committee and include an up-todate curriculum vitae clearly outlining the value of the appointment to the faculty, school, department and institution.
- the appointment will be made by the President on the recommendation of the Tributes Committee; the President will advise the Board of Governors of the appointment.
