Presentation

The Chair welcomed Janine Hadfield to the Board Meeting.

Wellness Centre

Janine Hadfield and Dianne Symonds share the duties of co-ordinating the Wellness Centre, which is located on the Surrey campus. The Wellness Centre serves students, employees and community residents in Kwantlen's region. The purpose of the Wellness Centre is to provide learning opportunities for students, which contributes to Centre development, and to promote health and wellness.

The key to wellness is identifying your health issues, goals and actions to be taken; integrating what you have learned into your everyday life; and participating in the development of programs that are meaningful to you.

Various programs at the Wellness Centre include breast self-examination clinics, relax and unwind sessions for employees, and Wellness Wednesdays promoting health topics.

The Passport to Wellness Program begins in January 2002. It is a one-year journey of activities that encourages employees to take control over their wellness. It is to act as a catalyst in helping employees motivate themselves and to evaluate the effectiveness of this program in improving and meeting the needs of employees.

President's Monitoring Report

Human Resources Report / Liz McKinlay

Ms. McKinlay presented an update on grievances and arbitrations. Included were the dates of filing as the Board requested.

Negotiations with the Kwantlen Faculty Association (KFA) have not progressed. Kwantlen and the KFA have jointly agreed to apply to the Labour Relations Board for mediation.

Board Budget Status Report / Linda Coyle

The Board Budget as of 11 September 2001 was presented for review. The Board is on target with its expenses.

Core Services Review - Draft #6 / Skip Triplett

The Core Services Review Draft #6 was distributed for the Board's information. Many of the Board's comments on Draft #2 were taken into account. The covering letter makes the point that Kwantlen could not properly consult with the Board and Education Council prior to the Ministry's deadline. This report represents extensive work by the senior administrations of the five university colleges. Once the final version is submitted to the Ministry, the university colleges will ask for input from their Boards and Education Councils.

President's Update

Skip Triplett and two other university college presidents met with the Honourable Shirley Bond, Minister of Advanced Education, last week. After hearing what they had to say, Ms. Bond was very excited about university colleges and their potential. The university college presidents meet with Ms. Bond again in mid-October.

Mr. Triplett also met with Lyn Tait, the Assistant Deputy Minister of Advanced Education.

Mr. Triplett spoke with Gordon Hogg, MLA Surrey White Rock about possible options regarding Tech BC and our potential Cloverdale campus.

Surrey City Council passed a resolution, which they forwarded to Minister Bond, supporting building Kwantlen's Cloverdale campus.

Cloverdale Status Report / Linda Coyle

Linda Coyle met with the government's Facilities personnel. Facilities will cover Kwantlen's site preparation costs to date, but will not allow pre-loading of the site.

As opportunities occur, Skip Triplett will remind the MLAs in Kwantlen's region of the pluses of a Cloverdale campus.
