1. Call to Order and Territorial Acknowledgement

The Chair, Bruce Choy, called the meeting to order at 4:00 p.m.

2. Approval of Agenda

Mike Larsen moved the agenda be approved as circulated.

The motion carried.

#### 3. Approval of Minutes, September 29, 2025

Winston Sayson moved the minutes be approved as circulated.

#### 4. Chair's Report

#### 4.1. Vice-Chancellor's Report to Senate

Vice-Chancellor and President Bruce Choy presented his written report and added the following updates:

- The search for a new University Librarian has begun following Todd Mundle's announced retirement in May 2026. A call for a Senate representative on the search committee has been issued.
- The Chancellor Search Committee has convened and aims to recommend a candidate for Senate endorsement in early 2026, with installation planned for the June convocation ceremony.
- The Chair emphasized the importance of campus safety as a foundational condition for learning, and stressed the role of faculty engagement in compliance and emergency preparedness.

#### 4.2. Provost's Report to Senate

Provost Diane Purvey presented her written report and highlighted the following:

- Groundbreaking for the new daycare on the Surrey campus will begin next month, and the
  project includes a collaboration between the Faculty of Trades and the Facilities
  department that will allow trades students to participate in on-site job fairs and
  walkthroughs.
- The Deans of Arts and Design have launched a joint initiative called Creative Connections
  to showcase KPU's creative programs to external audiences, highlighting opportunities for
  collaboration and community engagement.
- The Faculty of Health, in partnership with the Fraser Health Authority, has established an LPN to BSN program that enables Licensed Practical Nurses to continue working while upgrading to a Bachelor of Science in Nursing.
- The Melville School of Business has collaborated with the Tsawwassen First Nation to deliver an Indigenous Entrepreneurship program, which was successfully piloted earlier this year and will be offered again in spring 2026.
- Students in the Faculty of Science's Turf Management program had the opportunity to visit a site in Abbotsford where hybrid sod for the FIFA World Cup is being developed, allowing them to apply classroom learning to real-world industry practice.

#### 5. Approval of Graduates

Each Dean presented the list of graduates for their respective faculties.

Diane Purvey moved that Senate approve the list of graduates as recommended by the Registrar.

#### 6. Senate Standing Committee on Curriculum

Catherine Schwichtenberg, Chair of the SSCC, presented her written report.

#### 6.1. Requisite Removal: HSCI

This change removes prerequisites that are unrelated to course content and pose unnecessary barriers, particularly for international and mature students.

Catherine Schwichtenberg moved that Senate approve the removal of all pre-requisite course requirements from HSCI 1115, effective January 1, 2026.

The motion carried.

#### 6.2. Requisite Removal: EDAS

This change removes barriers to student registration that are caused by pre- or co-requisites.

Catherine Schwichtenberg moved that Senate approve the removal of all pre-requisite course requirements from EDAS 1240, EDAS 1282, EDAS 1305, and EDAS 2121, effective January 1, 2026.

The motion carried.

#### 6.3. Admissions Change: Citation in Entertainment Arts

The proposal removes the portfolio submission requirement, which had deterred otherwise qualified applicants. The change also reduces administrative costs and streamlines admission processing.

Catherine Schwichtenberg moved that Senate approve the revision to the admissions requirements for the Certificate in Foundation in Entertainment Arts, effective September 1, 2026.

The motion carried.

#### 7. Senate Executive Committee

The Senate Executive Committee approved this agenda on October 17, 2025.

# Report to Senate Dr. Bruce Choy, Vice Chancellor November 24, 2025

#### 1. Purpose and Context

1.1. The purpose of this report is to provide a summary update of key activities and events at the University and the environment we are operating in for the prior period. It is for information only.

#### 2. Recommendation

2.1. It is recommended that the Senate note this report.

#### 3. Federal Budget and Future Implications

- 3.1. Canada's Finance Minister François-Philippe Champagne delivered the 2025 Federal Budget in the House of Commons on November 4, 2025. It had significant implications to KPU's nearterm future confirming the significant threat to the institution's revenue streams from international student fees is here to stay. It locks in the structural change in which as older cohorts of international students graduate from KPU that they will not be replaced in the same numbers.
- 3.1.1. The federal government has set significantly lower targets for international student permits, with annual caps for 155,000 in 2026, and 150,000 in 2027 and the same in 2028 (where the 2025 target was 305,900 but had included research masters and PhD students). Government actions to date have resulted in a 60% decline in new international student arrivals compared to 2024 levels. This policy target ensures international student levels will continue the downward trajectory.
- 3.1.2. The number of new permanent residents will be set at 380,000 per year for 2026, 2027, and 2028, slightly lower than the 395,000 planned for 2025. Offsetting the narrowing of this pathway for our graduates to stay in Canada, there is to be a shift to prioritize economic migrants to make up 64% of new permanent residents, an increase up from 59%.

- 3.1.3. The announcement of these two policies continues the global brand damage to Canadian educational services. International students in key markets are expressing concern about investing in a future in Canada and are actively choosing other options for a western higher education credential.
- 3.2. Other signature policies that on face-value look to enhance our sector, also do not provide any direct support from a specific KPU perspective:
- 3.2.1. Up to \$120m has been allocated to recruiting top academic talent to universities. Politically, this is targeting discontent about academic freedom and political influence on research in the U.S. and is to disproportionally benefit U15 research universities. It distorts the employment market and disadvantages the mobility of local academics.
- 3.2.2. The federal budget had a focus on enhancing skilled trade capacity needed to support ambitious infrastructure, nation building programs. However, these funds are primarily being channeled into union-based apprenticeship training rather than directed into college/polytechnic institutes such as KPU.
- 3.2.3. 'Big bets' in research sees the lion's share of new research funding in the fields of artificial intelligence and quantum computing (with over \$1 billion dollars allocated over five years). Neither field are research areas of where KPU has a competitive advantage and has high infrastructure/compute investment needs.

#### 4. Looking towards other opportunities from Victoria/Ottawa

- 4.1. On 14 November, Premier David Eby and Minister Jessie Sunner (Post-Secondary and Future Skills) announced a significant funding package for skilled trades training. \$54 million will be allocated across all B.C. trades training service providers next year scaling up over three years. Allocation rules are still to be announced as to how much KPU will directly benefit. It will be used to increase per-seat funding as well as to address waitlists for targeted trades.
- 4.2. I spent four days in Ottawa in early November along with other university and polytechnic Presidents, as part of lobbying efforts across different ministries. Despite the disappointing headlines from the budget and IRCC, there were other opportunities to diversify revenues.
- 4.2.1. Natural Sciences and Engineering Research Council (NSERC) of Canada has expanded several of their initiatives including a sizable increased commitment to their Research Chairs program. KPU has been building a successful track record in recent years at being awarded such grants.
- 4.2.2. Department of National Defense expressed interest to partner specifically with polytechnics to help them advance their Arctic strategic priority. They had an interest in research on how to operate in uber-cold environments and have been given significant funding for this.
- 4.2.3. Ministry of Jobs and Family is keen to fund initiatives that directly address the youth unemployment. Youth unemployment (ages 15 to 24 actively seeking jobs) is viewed as at a tipping point, being twice that of the overall unemployment rate and close to a 10-year high.

## 5. Select University Activity Highlights

- 5.1. The Faculty of Art continues to lead the way to accessible education, with Criminology's Open-Access Textbook launch occurring on 5 November offering their latest Open Education Resource: Research Methods in Criminology: Integrated Western and Indigenous Approaches in the Canadian Context, edited by KPU faculty Shereen Hassan and Carroll Boydell.
- 5.2. The Melville School of Business was the title sponsor for the 2025 Canadian Digital Marketing Summit held on the Surrey campus on 2 October. This partnership offered a platform to showcase Melville's deep connection with industry. The event attracted over 200 in-person attendees, including marketing professionals, business leaders, and educators.

#### 6. Notable Partnerships, Grants and Donations

- 6.1. As verbally updated in our October meeting, two KPU researchers were awarded coveted Canadian Research Chairs on 22 October. Dr Lisa Monchalin and Dr Cayley Velazquez have secured over \$1 million for research funding for their respective fields. Health scientist Dr Velazquez studies the intersection of race, food and health to better understand what is impacting the availability, accessibility and utilization of food here in Surrey. Criminologist Dr Monchalin has a long-standing commitment of investigating miscarriages of justice and false accusations in Canada, particularly those affecting Indigenous Peoples. These funds will accelerate KPU's applied research impacts and outputs.
- 6.2. Following from the successful pilot of a bespoke program for EllisDon, the Faculty of Trades and Technology have secured a contract to provide EMBERS Canada (Eastside Movement for Business and Economic Renewal Society) providing three cohorts of trades training in Construction Worker Level 1 scheduled for March to August 2026.

#### 7. Other

- 7.1. A large focus as I enter my third month at KPU has been attending events with external stakeholders. These include meeting B.C. Premier Eby, other MPs and MLAs, federal and provincial Ministers and their bureaucrats, Vancouver mayor Sims, KPU donors and alumni, and senior B.C. corporate leaders. It also included my first external speaking role representing KPU, at the Ascend Canada Pan-Asian leadership annual gala event.
- 7.2. Internally, I joined other KPU volunteers at the annual Movember bike-a-thon to raise funds for men's health initiatives. This is a grassroots event started by the electrical trades department in 2022 which involved volunteer riders cycling in relay, continuously for 24-hours (I also got to see which KPU colleagues are so dedicated that they show up in the middle of the night!). Additionally, and article by the student newspaper, The Runner, featuring Wilson School of Design Dean, Andhra Goundrey, and myself was published in early November to introduce us to the KPU student community.

#### Context and Background

In 2018, KPU created VISION 2023 which served as KPU's Strategic Plan, with revised Mission, Vision and Values statements and 15 goals organized under five interconnected themes. Vision 2026 was approved by the Board of Governos in May 2023. It added a new goal on the health and wellness of students and employees, a new set of values and other language improvements.

#### **Key Messages**

- 1. Vision 2026 will be expiring soon. A new Strategic Plan needs to be developed to provide clear direction and leadership to the KPU Community. In order to have a new plan in place by the end of the governance year (June 2026), the process and consultations will need to start in early 2026.
- 2. GV10, Mission, Vision and Values Development and Amendment Policy and Procedures, requires that the Board of Governors and Senate receive and approve any requests to amend KPU's mission, vision and values (in whole or in part).

### Implications/Risks

If a review of the Strategic Plan does not start in early 2026, the consultations may not be completed on time and KPU could have an out of date plan.

## **Policy and Academic Affairs Team**

#### **Policy Updates**

Draft Policy and Procedure AC15 Digital Credentials (Non-Credit) was approved by Board of Governors on October 1, 2025. The new Policy and Procedure will become effective on January 1, 2026. In the coming months, the Curricular Support unit, Teaching and Learning Commons, Office of the Registrar, Continuing and Professional Studies, and the Vice Chair of Senate will be meeting to discuss key issues and operational considerations in preparation for a January 1, 2026 implementation.

The Policy and Academic Affairs (PAA) team is currently supporting the Provost's office and the Office of the Registrar in the revision for Procedure AC6 Recognition of Prior Learning (RPL), with the goal to complete the consultation and revision process before the end of 2025-2026 academic year. The goal of the procedure revision is to bring added clarity, ensure alignment with current practices, support institutional innovation, and further strengthen KPU's ability to provide accessible pathways for applicants and students at KPU through a student-centered RPL framework.

#### **Graduate Studies at KPU**

The PAA team created an initial draft of the Graduate Student Handbook on the Pressbook platform in June 2025 and completed internal consultations on the Handbook in August 2025. The team continues to conduct research and internal consultations on graduate studies regulation topics relating to graduate studies, including minimum admission requirements, academic progress, leave of absence, time limit for completion, graduate thesis or project extension, and minimum English requirements. Over the next few months, the team will support the Graduate Studies Council in its work to revise relevant policies and procedures, conduct internal consultations, and develop additional regulations for Senate's approval before the end of the 2025-2026 academic year.

The Flexible Learning Office facilitated the forging of partnership between KPU and the Progressive Intercultural Community Services Society (PICS), an organization that supports newcomers to Canada through settlement programs and services. The partnership was formalized with the signing of a Letter of Understanding on October 14, 2025 at the Surrey campus.

Representing KPU were **Dr. Asma Sayed**, Vice President for Equity & Inclusive Communities, and **Dr. David Burns**, Associate Vice President, Academic. **Raj Brar**, Director of Career Services at PICS, signed on behalf of the organization. **Mr. Brar** oversees PICS' Foreign Credentials Recognition Program that provides financial assistance, coaching, and employment support to internationally trained professionals.

This partnership includes referral pathways to KPU, delivery of short courses and micro-credentials, prior learning assessments for eligible learners, and joint initiatives on equity, diversity, and inclusion, and anti-racism. It represents a meaningful opportunity for KPU to deepen its engagement and impact within the community.

# Work Integrated Learning Team Lead Advisor on Work Integrated Learning Team Dr. Larissa Petrillo

Many programs are considering adding new Work-Integrated Learning components. This term, consultations have taken place with Entrepreneurial Leadership, Entertainment Arts, Educational Studies, Fine Arts, and CADD Technologies.

In KPU's Horticulture program, the students have already pruned all the trees on campus, so, they have moved off-campus! Working with the City of Surrey, Arboriculture students have pruned the fruit trees at Orchard Park for two years in a row. They pruned all the healthy trees, pulled the old stakes, installed new ones, and noted all diseased trees. **Tomasz Gradowski** and the students received very positive feedback from local residents about their transformed park, and the event gave KPU a great opportunity to showcase the "KPU Horticulture" logo in the community.

#### **COMMITTEE REPORT**

On November 5, 2025, the Senate Senate Standing Committee on Curriculum recommended that the Senate revise the issuance criteria for Micro-credentials for previously approved 10 micro credentials to be a letter grade of C.

On October 16, 2025, the Senate Micro Credential Committee recommended that the Senate Standing Committee on Curriculum recommend that the Senate revise the issuance criteria for Microcredentials for previously approved 10 micro credentials to be a letter grade of C.

### **Context and Background**

The Senate has approved Micro-credentials and the criteria for their issuance. Several software products are involved in recording student achievement of these criteria and to issue the digital open badge.

Success criteria that indicate a specific level of achievement in a course—for micro-credentials embedded across multiple courses delivered over several semesters—are required to be awarded based on letter grades due to an operational limitation to the way data can be collected and processed within the badging issuance software over many semesters.

For the 10 approved Micro-credential proposals listed below, this motion seeks to request permission to convert that criterion to letter grade of C for the following Micro-Credentials:

- 1. Micro-Credential in Brewing
- 2. Micro-Credential in Business of Brewing

- 3. Micro-Credential in Beer Sensory Evaluation
- 4. Micro-Credential in Brewing Science
- 5. Introduction to Concepts in Applied Behaviour Analysis in K-12 Schools
- 6. Micro-Credential in Psychology, Marketing and Design
- 7. Micro-Credential in Psychology and Organizational Behavior
- 8. Micro-Credential in Quantitative and Qualitative Psychology Research
- 9. Micro-credential in Human Resources Essentials
- 10. Micro-credential in Emotional Intelligence for Human Resource

#### **Key Messages**

- 1. The Senate has approved criteria for the issuance of the stated Micro-credentials.
- 2. For micro-credentials that are embedded in multiple courses achievement is defined as a letter grade for the entire course as opposed to individual components of the course of the overall percentage as these cannot be automated and the data cannot be retrieved over a lengthy period.

## Context and Background

The Bachelor of Psychiatric Nursing (BPN) program currently exists as a "1 + 3" program wherein students complete 30 credits of prescribed and elective courses (year 1) outside of the program and then apply to the BPN program to complete the remaining 91 credits through 6 terms of study. The recommended program revision incorporates the 30 credits directly into the BPN Program making it an 8-term program. This recommended program revision does not change any of the curricular

requirements but changes the admission requirements as prospective students will apply directly to the BPN program wherein they will complete the 30 credits as term 1 and 2 of the BPN program. This program change will permit direct entry from high school applications, increasing accessibility and support program sustainability through increased enrollments. In addition, the proposed delivery model for the BPN program shifts to approximately 30% in-person and 70% online instruction, enhancing flexibility, accessibility, and scalability. This blended approach supports diverse learning styles, work-life balance, and broader access for students facing geographical or personal barriers, as the KPU BPN program is one of two programs in the province.

#### **Key Messages**

- 1. Current admission requirements of 30 credits prescribed, and elective courses moved into Term 1 and Term 2 of the BPN program making the program eight terms instead of six.
- 2. New admission requirements for entry to the program based upon the pre-requisites for Term 1 prescribed courses.
- 3. Proposed changes only apply to new student cohorts entering under the revised 8-term structure. Current students will continue in the existing 6-term BPN program without disruption.
- 4. Course delivery model changes shifting to a blended model with approximately 30% in-person and 70% online instruction.

Inperson sessions will focus on essential hands-on skills, clinical simulation, and high-impact learning activities that require direct interaction. This change aligns with KPU's commitment to innovative, student-centred education and leverages robust support from the Faculty of Health, Teaching and Learning Commons, and affiliated platforms (e.g., Elsevier, Laerdal). By reducing reliance on physical classroom space, the program optimizes resource allocation while accommodating larger, more diverse cohorts, including international students. The new format prepares graduates for modern psychiatric nursing practice by integrating technology-driven learning with essential face-to-face clinical skill development.

# **Admission Requirements**

In addition to the Faculty's Admission Requirements, which consist of KPU's undergraduate English Proficiency Requirement (https://calendar.kpu.ca/admissions/english-proficiency-requirements/), the following program admission requirements apply:

- Anatomy and Physiology 12 (or equivalent) with a minimum grade of C+; or an undergraduate BIOL course with a minimum grade of C+
- Chemistry 11 or 12 (or equivalent) with a minimum grade of C+; or an undergraduate CHEM course with a minimum grade of C+
- BIOL 1150 or BIOL 1160 with a minimum grade of C+
- BIOL 1250 or BIOL 1260 with a minimum grade of C+
- ENGL 1100 with a minimum grade of C+
- PSYC 1100 with a minimum grade of C+
- PSYC 1200 with a minimum grade of C+
- 15 credits of undergraduate-level courses with a minimum grade of C+

Admission selection will be based on the highest admission GPA of the above required courses.

All newly admitted students to the Bachelor of Psychiatric Nursing program will be required to provide:

- Valid Canadian CPR Basic Life Support (BLS) or CPR Health Care Provider (HCP) (Note: CPR certification must remain current throughout the program.)
- · Current Standard First Aid Certificate
- An acceptable Criminal Record Check through the Ministry of Public Safety and Solicitor General's Criminal Records Review Program within 6 months prior to the start of the program.
  - International applicants are required to provide a Criminal Record Search with the Vulnerable Sector from their country of origin.
- Immunization Record Form reflecting required immunizations as per Practice Education Guidelines for BC. Note: Practice Education Guidelines (PEG) for BC outline immunizations for vaccine preventable communicable diseases required by students for participation in practice experiences. KPU Faculty of Health is required to comply with these requirements. Students that are unvaccinated may not be able to be accepted into the program. Students who are accepted into the program will also be required to maintain immunizations as per the PEG.

To ensure a pathway is available for specific student populations in the Bachelor of Psychiatric Nursing, the following program reserves are in place for each intake: three (3) seats will be reserved for graduates of KPU's *Certificate in Health Care Assistant* program, and three (3) seats for self-declared Indigenous students. Any reserved seats that are not offered to the above noted specific student population will be offered to the general pool of qualified BPN applicants.

#### **Advanced Standing**

In addition to the program admission requirements, applicants may be eligible for advanced standing into Year 2 if they have completed all curricular requirements of Year 1 (Terms 1 and 2). Advanced standing admission is determined by seat availability.

# **Continuance Requirements**

Students must maintain a cumulative GPA of 2.67 with a minimum grade of C+ in all required courses or with Standard Grading and a grade of MAS in all courses with Mastery Grading. Non-adherence to these requirements may result in removal from the program.



Students must complete all program courses in each semester before they can continue to the next semester. Re-entry into the program will be based on seat <u>availability</u>. <u>availability and approval by the Program Admissions and Progressions Committee</u>. Seat availability will be based on priority for students who progress with their original cohort.

# **Curricular Requirements**

Students pursuing a Bachelor of Psychiatric Nursing must complete a minimum of 121 <u>credits.</u> <u>credits, including the courses used to fulfill this program's admission requirements.</u>

The maximum allowable time that students have to complete all of the following requirements for graduation is seven years.

The program is recognized by The British Columbia College of Nurses and Midwives (BCCNM).

The Kwantlen Polytechnic University Bachelor of Psychiatric Nursing (BPN) program philosophy consists of three guiding principles and six core concepts. These provide the philosophical foundation for the BPN program and basic assumptions that are inter-woven through all aspects of the BPN program curriculum and underpin its' philosophical framework. They provide grounding in health promotion, therapeutic relationship and diversity.

The core concepts are articulated and place the client at the center of our model. These include: client centeredness, being, situatedness, choice, professionalism, and teaching and learning. The person (client) is considered within the context of their culture, religion, ethnicity, race, historical experiences, spirituality and abilities. Diversity, equity, and social justice are values running through the entire curriculum. This lens considers the impact of the environment, social determinants of health, definitions of health and illness, and the impact of treatment, prevention, and promotion on a person's well-being.

The BPN program is developed in the context of psychiatric nursing theory based on best practice and the therapeutic use of self in interpersonal relationships. A health promotion perspective has been used to organize and construct the curriculum. This shift in focus from illness to health represents a deliberate move away from a disease model, to a model focusing on the person's experience with health and healing (Austin and Boyd, 2015). Inherent to these orientations is the use of teaching methodologies, which encourage the development of analytical and critical thinking based on praxis, and the discovery of personal meaning and personal power.

The BPN program philosophy recognizes the foundational role of praxis in psychiatric nursing theory and recognizes that psychiatric nursing practice requires thoughtful, reflective action. To assist in actualizing the concept of praxis, nursing practice experiences are integrated throughout the program of studies. The concept of praxis is used to guide learners to critically reflect on their practice and on their application of psychiatric nursing knowledge and clinical judgment within the practice setting.

Students who enroll in the program will receive a student resource manual that provides information regarding program guidelines. Students are responsible for familiarizing themselves with University policies and BPN program guidelines.

#### **COMMITTEE REPORT**

On November 12, 2025, the Joint Senate Standing Committees on Academic Planning and Priorities and on University Budget recommended that Senate endorse and advise the President that the draft Fiscal 2026-27 Budget aligns with the Budget Principles and Priorities, as presented.

## Context and Background

**University Act, Section 62(2):** The President must prepare and submit to the Board an annual budget in consultation with the appropriate standing committee(s) of the Senate.

**SSC Academic Planning and Priorities Mandate**: Advise the Senate Standing Committee on University Budget on the academic priorities for the allocation of funds.

**SSC University Budget Mandate**: On behalf of the Senate, and in consultation with the Senate Standing Committee on Academic Planning and Priorities:

- Advise the President and Vice-Presidents on the review and development of academic budgetary priorities, major capital plans, and the allocation of funds
- Present the annual University budget to Senate.

On May 30, 2025, the University Budget Principles and Priorities were presented to the Joint Senate Standing Committees on Academic Planning and Priorities and on University Budget.

# **Key Messages**

- 1. As per the fiscal 2026-27 Budget Principles and Priorities, the proposed budget will focus on student success, support of KPU's core activities and will be balanced. The proposed budget is also aligned with KPU's Mandate Letter from the Ministry.
- 2. KPU's ability to adhere to the proposed budget includes assumptions around achieving specific international student enrollment targets and realizing its associated impact on international tuition revenue. This assumption has been continually reviewed throughout the budget process and may be revisited as new information becomes available.
- 3. The draft 2026-27 budget proposes decreases from the prior year of approximately \$31 million in revenues and \$31 million in expenses when compared to the Fiscal 2025-26 Budget, in addition to the decreases of \$12 million in revenues and \$12 million in expenses from the 2024-25 Budget.

# Budget Context & Influences

- International Students:
  - Ongoing Downward Trend
- Federal Government Policy:

# Federal policy impact on international student permits results in a 30% drop in KPU revenues over 3 years

- International Student Tuition and Fees
  - FY27 = \$46M or 18% of KPU Total Revenue
  - FY24 = \$134M or 46% of KPU Total Revenue
  - FY24 to FY27 = \$88M decline
- International Trends
  - Decline Continuing Students
  - FY26 Equivalent New Students
  - Scenario planning +/- \$3M
- Domestic Students Flat
  - FY27 = \$41M
  - FY24 = \$38M



# Provincial Operating Grant does not fluctuate with student numbers

- Operating Grant Block Funded no adjustment for student #'s = \$113M of Revenue
- Minimal increase in Operating Grant assumed for Salary increases
- Limited Domestic Tuition rate adjustments = 2%



# KPU investment income is volatile and market dependent. We should not depend on this level of funding in future years.

- Investment and Interest income
  - Impact of 2024 Land Sale
    - Held for Purpose Indigenous Fund, Student Awards
  - Reduction in Investment Holdings
    - Spending of deferred grants, capital investments in KPU future
  - Volatility in Markets returns and declining interest rates

# Deferred Operating funds only approved to be spent on one-time, time limited and targeted expenditures

- Deferred Operating Grants \$83M
- One-time source of funds cannot support ongoing operating expenses
- Specified usage One-time investments in EDI, Health & Safety, Planning, Accessibility, etc.
- Time Limited Ministry approval in place until FY28



# Transformation is required given 70% of expenses directly relate to staffing.

- Salaries and Benefits are ~70% of KPU's total expenditures
- Budget Rightsizing
  - Underutilized Faculty Contract staffing budgets have been removed in FY26 resulting in FY27 of Faculty budgets being reduced by ~\$11M plus benefits
- Estimated Reduction Targets
  - Reductions in Staffing are unavoidable
  - Faculty larger reduction in FY26 directly tied to student #'s
  - BCGEU and Administrative staff larger reduction in FY27 as strategic decisions are made
- Collective Agreement & other salary increases Estimates included



# Non-Salary includes targeted reductions and Contingency held to buffer uncertainty

- Non-salary reduction targets
  - -\$5M reduction FY27 (-\$3M FY26)
- Contingency considers risk in both revenues and non-salary expenses
  - Buffers Against Uncertainty



# Capital investments are responsible level of reinvestment and focused on strategic priorities

- Annual Capital Renewals and Refreshes = \$7.1M
- Continuation of projects that were approved in prior years = \$6.7M
- Priority Balanced against Affordability = \$1.6M
- Budget Principle Capital Expenditure Controls -KPU's self funded amortization remains less than 5% of Operating Expense

# Chair's Report to Senate Senate Standing Committee on Policy November 4, 2025

A short meeting of the Policy committee was held via MS Teams on November 4, with 6 voting members present along with several non-voting members.

The vice-chair of Senate provided the committee with a Notice of Election for committee chair at the next meeting.

There were two items of information from the Policy Office: first, the Phase 1 posting for Policy SR10 Travel Risk Management is underway until November 10. The committee opted in for consultation on this policy, so it will return to the committee later in the governance process.

Second, Josephine Chan indicated that an omnibus approach to addressing Generative AI in KPU policy does not appear to be necessary at this time according to the analysis done in her office over the last several months. Instead, Gen AI will be addressed as necessary when policies come up for revision or renewal.

Finally, Josephine Chan, Special Advisor to the Provost on Policy and Academic Affairs, referred the committee to her report, which mentioned that Policy AC15 Digital Credentials (non-credit) was approved by the Board of Governors on October 1, and will be implemented January 1, 2026, and that an initial draft of the Graduate Student Handbook on the Pressbook platform was completed in June and internal consultations completed in August, 2025. The PAA team continues to support the Graduate Studies Council to "revise relevant policies and procedures, conduct consultations, and develop additional regulations for Senate's approval before the end of the 2025-2026 academic year."

# Chair's Report to Senate Senate Standing Committee on Research October 23, 2025

This was the SSCR's first meeting of the 2025-2026 academic year, on its new schedule
alternating meetings with the SSCT&L every other month. The new President attended the
first portion of the meeting.

# • Chair's report

- O The Chair delivered a verbal report addressing the cancellation of the three previous Committee meetings due to the lack of agenda item submissions, and invited discussion as to the utility of having meetings in the absence of items that are suitable to pass along to Senate. Members were split on this matter. Some members value the committee as one of the only opportunities to hear about and discuss research matters at the university, and would prefer meetings not be canceled; others do not see meeting in the absence of legitimate Senate items as a productive use of time. A member suggested the addition of standing items to the agenda which would be addressed at every meeting, perhaps one item per mandate point.
- Introductions & discussion of the mandate
  - The purpose of the SSCR and whether it is the appropriate platform for research matters and initiatives members would like to see addressed was debated. Again, some members value it for the exchange of information about research activities even in the absence of agenda items that fall within Senate's mandate, while others feel that the limitations imposed by the structure and mandate as a Senate subcommittee hamper its usefulness. The Chair reminded the committee of her investigation in early 2025 into the direction and governance of research at other universities in the province, which revealed a roughly even split between two main approaches: one, Senate research subcommittees like ours, and the other, Research Advisory Councils independent of the bicameral governance system, which have broader membership composition and directly advise the research administration. It was noted that all of the Senate subcommittees will likely undergo review in the near future to align them with the new president's approach to Senate, which will present an opportunity to refine the mandate.

- Discussion of the AVPRI's monthly report to the Committee
  - The AVPRI sought feedback from the committee regarding the utility and format of their monthly (now bimonthly) report presented to the SSCR. The AVPRI confirmed this report only goes to the SSCR, and constitutes a great deal of work both for his office and for contributors. Some members said they do read the report in order to keep current on research activities across the university, while others questioned whether the amount of work required to generate the report was warranted for such a limited audience. The general consensus was that the AVPRI's office would explore a more diverse and targeted outreach strategy for the information currently consolidated in the report, while continuing to provide the report to the Committee in the interim.
- The AVPRI then delivered said report, summarizing some key activities over recent months.
- Research software
  - The Chair raised a discussion about difficulties researchers face in navigating the institutional research software landscape, both in terms of knowing which software is acceptable for use with different levels of data sensitivity, and knowing what software is available and where to obtain the licenses. An option for a self-hosted, secure, institutional data capture (survey) program was suggested (REDcap) which prompted the AVPRI and AVPT&L to mention they were in discussion with the AVP Planning & Accountability to investigate a similar program (JATOS) suggested by a faculty member. The role of the SSCR in raising and acting on such research support initiatives was discussed. In this case, given that an investigation of related software was already in progress, the Chair felt satisfied leaving the preliminary groundwork to the aforementioned AVPs. Some members warned that top-down imposition of institutional research tools without sufficient community consultation was likely to be poorly received
- Draft RS1 policy (research on humans)
  - o Finally, the draft update to policy RS1 was included in the agenda package as an information item; the draft was considered complete and scheduled to be presented to the Board of Governors in November. It came as a surprise to most of the committee to discover that, despite the SSCR's mandate to "Advise Senate on academic matters related to research at the University including: Institutional policies and procedures related to research", Senate is not an approving jurisdiction of RS1 or any other current institutional research policy; hence, neither Senate nor the SSCR must be consulted or give approval for these policies to move forward. The Chair created an action item to reach out to the Policy office to investigate this state of affairs further.

# Context and Background

# **University Act**

Sec 36 (4) states: "If a vacancy arises on the senate, the vacancy must be filled, in the case of an elected member, in the manner specified by the senate."

Sec 36 (6) states: "The secretary of the senate must enter a declaration of the vacancy in the minutes of the senate."

Sec 36(7) states: "A declaration under subsection (6) is conclusive evidence of the vacancy."

# **University Board of Governors & Senate Rules and Regulations**

If a vacancy arises on the senate, the vacancy will be filled, in the case of an appointed member, by the body possessing the power of appointment, or in the case of an elected member, in the manner specified below.

If a vacancy occurs on senate, in the case of an elected member it shall be filled by the candidate who received the most votes among those who were nominated but not elected in the most recent election. In the event the seat was filled by acclamation, the following steps will occur:

- 1. If the seat is declared vacant before the end of the call for nominations period for the upcoming election, the seat will be attempted to be filled in the upcoming election.
- 2. If a seat is declared vacant after the call for nominations period for the upcoming election period has closed, the seat will be attempted to be filled in the subsequent election or byelection.
- 3. the outstanding months of the term remaining on the vacant seat will be added to term of office when a replacement is sought.
- 4. If all the seats in a given constituency are acclaimed, a random selection from the acclaimed candidates will occur to assign the remaining term of office. If more than one seat is being elected in this grouping, then the candidate who receives the most votes will be awarded the

extended term of office. The seat will be filled in the upcoming election or byelection as appropriate.

The Secretary of the Senate (the Registrar) must enter a declaration of the vacancy in the minutes of the senate. A declaration under subsection 36(6) is conclusive evidence of the vacancy.

A person appointed or elected to fill a vacancy holds office for the remainder of the term for which the person's predecessor was appointed or elected. A vacancy on the senate does not impair the authority of the remaining members of the senate to act.

# **Key Messages**

1. Melville School of Business Senator, Judy Benevides, resigned from Senate, effective, October 28, 2025, and a replacement will be sought in the spring 2026 election.
