

KWANTLEN POLYTECHNIC UNIVERSITY - 2024 CAREER DAY - STAMP CONTEST

Official Contest Rules and Regulations

Participation in the **2024 CAREER DAY – STAMP CONTEST** (the "Contest") constitutes the entrant's full and unconditional agreement with and acceptance of these Official Contest Rules and Regulations ("Official Rules") and all decisions of Kwantlen Polytechnic University ("KPU") and its agents, which are final on all matters relating to the Contest.

1. ELIGIBILITY

Entrants must be current student or alumni of KPU aged 16 or older. Faculty and staff at KPU are not eligible. All provincial, municipal and federal laws and regulations apply.

2. HOW TO ENTER

On Tuesday, March 12, 2024 from 10:00 AM - 2:00 PM Pacific Standard Time (PST) in the Richmond Atrium, KPU Richmond, 8771 Lansdowne Road, Richmond, BC V6X 3X7 or on Wednesday, March 13, 2024 from 10:00 AM - 2:00 PM PST in Spruce Building 1001, KPU Surrey, 12666 72 Avenue, Surrey, BC V3W 2M8 attend the Career Day event, and chat with an exhibitor representative to collect stamps. Every 5 activity stamps collected, during the Contest Period (as defined below) earns the entrants one (1) entry into the Contest. (each an "Entry".) Maximum six (6) Entry(ies) can be earned per person.

To enter, entrants must attend either the KPU Richmond or KPU Surrey Job and Volunteer Fair and chat with an exhibitor representative to collect stamps. Every 5 activity stamps collected, during the Contest Period (as defined below) earns the entrants one (1) entry into the Contest. (each an "Entry".) Maximum six (6) Entry(ies) can be earned per person.

3. DEADLINES

The Contest begins at 10:00 AM PST on March 12, 2024 and ends at 2:00 PM PST on March 13, 2024 (the "Contest Period").

4. PRIZING

There are three (3) prizes to be awarded in connection with the Contest. Subject to and in accordance with the Prize Claim Conditions outlined below, each Selected Entrant will be awarded one (1) of the Prizes as follows:

- Guildford Mall Gift Card (valued at \$50 CAD)
- Stanley Mug 40 oz (valued at \$55 CAD) (the "Prizes")

No cash substitutions. Prizes must be accepted as awarded.

5. PRIZE CLAIM CONDITIONS

The selected entrant of the Entry drawn pursuant to the Contest Draw (the "Selected Entrant") will be announced on Friday, March 15, 2024 at 2:00 PM PT during an Instagram Live Session and a post will be shared via @kpucdc Instagram channel and winners contacted via the email address provided in the registration form. The Selected Entrant will have until 3:30pm PT on Tuesday, April 30, 2024 to claim the Prize.

In the event of a dispute as to the identity of the person who submitted the Entry to the person claiming the Prize, the authorized account holder of the email address associated with the Selected Entrants' submission will be deemed to be the Selected Entrant in question, unless otherwise determined by KPU.

In order to claim their Prize, the Selected Entrants must present themselves, with valid photo identification at the Surrey Main 136, KPU Surrey, 12666 72 Avenue, Surrey, BC V3W 2M8. Before being declared a "Winner", The Selected Entrants will be required to complete a written declaration and prize release form to be returned no later than 3:30 PM PST April 30, 2024 to KPU's Career Development Centre releasing KPU, related sponsors, advertising and promotional agencies, participating retailers, and all of their respective directors, officers, owners, partners, shareholders, employees, agents, representatives, successors and assigns from any

KPU and its authorized agents will collect, use and disclose the personal information you provide when you enter the Contest for the purposes of administering the Contest and Prize fulfillment. Such personal information is collected under the authority of and will be protected, used and disclosed in compliance with British Columbia's Freedom of Information and Protection of Privacy Act.

By entering the Contest and accepting a Prize pursuant to the Prize Claim Conditions above, the Winners authorize KPU and its advertising and promotional agencies and their respective employees or other representatives, to broadcast, publish and otherwise use the Winners' name, photograph, image, statements regarding the Contest and/or the Prizes, and voice for publicity purposes relating to the Contest, without any form of remuneration, approval or further notice.

7. RELEASE

By entering this Contest, you agree to indemnify, release and hold harmless, KPU, and its respective employees, and agents from and against any losses, damages, rights, claim or cause of action of any kind arising, in whole or in part, directly or indirectly, out of your breach of the Official Rules, the use of your Entry in the manner set forth in these Official Rules, use of the Prizes or otherwise resulting from your participating in the Contest.

8. MISCELLANEOUS

KPU reserves the right, in its sole discretion, to cancel or modify the Contest if fraud, technical failures, or anyone's actions destroys the integrity of the Contest, or if factors beyond KPU's control make it impossible for KPU to administer this Contest as planned. Entrants who have not complied with these Official Rules are subject to disqualification. The Prizes are not transferable and must be accepted as awarded with no substitutions in cash or otherwise, except at KPU's sole discretion. KPU reserves the right to substitute an alternate prize of equivalent or greater value if a Prize cannot be awarded as described. The Prizes will only be awarded pursuant to the Prize Claim Conditions outlined above. By entering this Contest, you agree to be bound by these Official Rules and the decisions of KPU. All decisions of KPU are final and binding in all matters relating to this Contest.
