



To Whom It May Concern:

Please accept this document as official definitions of Academic Schedule and Student Status as set out at Kwantlen Polytechnic University (KPU) for immigration purposes. This will benefit in answering any questions regarding student's academic enrollment.

Academic Schedule

KPU has three academic semesters per year (with an option for two intersession periods in each semester):

• Fall semester: September – December

Spring semester: January – AprilSummer semester: May – August

Enrolment Status

- A student who is enrolled in nine or more credit hours in a semester (including graduate, undergraduate, and preparatory courses) is considered to be full-time at KPU.
- A student who is registered in less than nine credit hours of study in a semester (including graduate, undergraduate, and preparatory courses) is considered to be part-time at KPU.

Authorized Leave

Under an extenuating or unforeseen circumstance that adversely affects the student's academic progress, an international student may request and be approved to take an authorized leave after a review of the request and any supplementary documentation. If the request is approved, the student will receive a Letter for Authorized Leave. The student does not become exempt from their obligations to comply with IRCC policies and requirements by receiving the Letter for Authorized Leave.

Scheduled Breaks

- One of the Spring (January to April), Summer (May to August), or Fall (September to December) terms in a calendar year (January to December) provided the student remains enrolled full-time at KPU in the term preceding the break and in the term following the break. For instance, if a student takes a break in the Summer 2025 term (May to August), they must enroll full-time in Spring 2025 term (January to April) and in the following Fall 2025 term (September to December).
- Break between academic semesters (i.e., the day after the posted full-term final exam period until the day before the start of the next full term semester).
- Reading break in the Spring semester.
- * During a scheduled break term (Fall, Spring, or Summer), a student who is eligible for off-campus work may choose to take full-time studies, part-time studies, or a break from studies and may work up to full-time hours. If a student withdraws from a course(s) during this semester, their scheduled break status does not change.

KPU's Response to COVID-19

Effective March 17, 2020, KPU shifted the majority of in-person classes to an online modality.
