Provides information on KPU's academic schedule, scheduled breaks, and enrollment status.</li> </ul>	<ul> <li>Once available, you are no longer eligible to work on or off campus and must stop work immediately.</li> <li>Apply for your PGWP as soon as you receive the PGWP Letter and meet all eligibility criteria to avoid gaps in work eligibility.</li> </ul>
	<ul> <li>Both documents will automatically be emailed to your</li> <li>KPU email within 3-5 business days after the Senate meeting.</li> </ul>	
Official Transcript	<ul> <li>Submit a copy of your official transcript in your application.</li> <li>Visit here for details on how to order it.</li> <li>Open the envelope and scan all pages of the transcript.</li> <li>Include one copy of the "Explanation of student academic record" that is on the back of each page.</li> </ul>	<ul> <li>Combine your transcript with the KPU Immigration Purpose Document and upload them together under the 'Recent Education Transcript' field.</li> <li>If you studied at multiple institutions, consult International Student Advisors for additional required documents.</li> </ul>
Proof of Language Proficiency	<ul> <li>As of November 1, 2024, proof of language ability in English or French is required.</li> <li>English Requirement: Canadian Language Benchmark 7.</li> <li>Accepted tests: CELPIP (General) IELTS (General Training) PTE (Core)</li> <li>French Requirement: Niveaux de competence linguistique canadiens (NCLC) 7 in all 4 areas.</li> <li>Accepted tests: TEF (Canada) TCF (Canada).</li> </ul>	<ul> <li>Language test results must be less than 2 years old at the time of application.</li> <li>Check the language test equivalency charts for specific score requirements.</li> </ul>
Passport	<ul> <li>Provide a scanned copy of your passport in a single PDF, including:</li> <li>Bio-data page (name and photo)</li> </ul>	<ul> <li>If your passport will expire soon, consider extending it before applying.</li> </ul>
