



KWANTLEN POLYTECHNIC UNIVERSITY – 2023 VIRTUAL FACULTY OF TRADES AND TECHNOLOGY COCA-COLA GIFT BAG CONTEST Official Contest Rules and Regulations

Participation in the 2023 VIRTUAL FACULTY OF TRADES AND TECHNOLOGY SHOWCASE RSVP COCA-COLA GIFT BAG CONTEST (the “Contest”) constitutes the entrant’s full and unconditional agreement with and acceptance of these Official Contest Rules and Regulations (“Official Rules”) and all decisions of Kwantlen Polytechnic University (“KPU”) and its agents, which are final on all matters relating to the Contest. Any questions, comments or complaints regarding the Contest must be directed to KPU.

1. ELIGIBILITY

Entrants to the Contest must be a resident of BC, age 16 or older. All provincial, municipal and federal laws and regulations apply. Faculty, current students, and staff at KPU are not eligible to enter the Contest.

2. HOW TO ENTER

Before 7:00pm Pacific Standard Time (PST) on Thursday, Mar 2, 2023 enter the contest online at <https://www.kpu.ca/showcase/trades> and RSVP to the Faculty of Trades and Technology Showcase to receive one (1) entry (each an “Entry”) into the Contest Draw (as defined below under Prizing). Maximum of one (1) Entry per person will be considered valid for entry into the Contest Draw.

No purchase is necessary in connection with the Contest, however, internet access is required to enter the Contest.

3. DEADLINES

The Contest begins at 12:00pm PST on September 27, 2022 and ends at 7:00pm PST on Mar 2, 2023 (the “Contest Period”).

4. PRIZING

There is one (1) prize to be awarded in connection with the Contest (the “Prize”) as follows:

- **1 x COCA COLA GIFT BAG, having an approximate value of \$120.00 (CAD)**

Total approximate value of all prizes, \$120(CAD)

The Prize is awarded subject to and in accordance with the Prize Claim Conditions outlined below. The selected entrant (as defined below under “Prize Claims Conditions”) will be awarded the Prize above. The Prize must be accepted as awarded. There are no cash substitutions for the Prize.

Odds of winning depend on the number of valid eligible Entries received.

5. PRIZE CLAIM CONDITIONS

At 12:00pm PST on Mar 6, 2023 one (1) Entry will be randomly drawn from all valid Entries received during the Contest Period (the “Contest Draw”).

The individual named on the Entry drawn pursuant to the Contest Draw (the “Selected Entrant”) will be notified by the email and phone number provided on the online entry form. The Selected Entrant will have ten (10) business days from the notification to claim the Prize. In the event of a dispute as to the identity of the person who submitted the Entry to the person claiming the Prize, the authorized account holder of the email address associated with the Selected Entrant’s submission will be deemed to be the Selected Entrant in question, unless otherwise determined by KPU.

In order to claim their Prize, the Selected Entrant must present themselves, with valid photo identification at the virtual KPU Community Engagement and Major Events Office via Microsoft Teams. Before being declared a “Winner”, the Selected Entrant must first correctly answer without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question to be administered at the time they present themselves at the virtual KPU Community Engagement and Major Events Office. The Selected Entrant will also be required to complete a written declaration and prize release form, releasing KPU, related sponsors, advertising and promotional agencies, participating retailers, and all of their respective directors, officers, owners, partners, shareholders, employees, agents, representatives, successors and assigns from any liability in connection with the Contest or the use or misuse or possession of the Prize. Where there is a return of winner notification as undeliverable or a failure to claim a Prize within the required time period or an inability to reach a Selected Entrant, including failures of the Selected Entrant to (i) provide proof of eligibility, (ii) provide release documents, (iii) provide other required documentation (if requested) in a timely manner, or (iv) correctly answer the skill-testing question, or other non-compliance with these Official Rules such event may result in disqualification, forfeiture of the Prize of that Selected Entrant and, at KPU’s sole discretion, selection of an alternate eligible entrant for the forfeited Prize, who will be subject to disqualification in the same manner.

6. PERSONAL INFORMATION

KPU and its authorized agents will collect, use and disclose the personal information you provide when you enter the Contest for the purposes of administering the Contest and Prize fulfillment. Such personal information is collected under the authority of and will be protected, used and disclosed in compliance with British Columbia's Freedom of Information and Protection of Privacy Act.

By entering the Contest and accepting a Prize pursuant to the Prize Claim Conditions above, the Winners authorize KPU and its advertising and promotional agencies and their respective employees or other representatives, to broadcast, publish and otherwise use the Winners' name, photograph, image, statements regarding the Contest and/or the Prize, and (or) voice for publicity purposes, without any form of remuneration, approval or further notice.

7. RELEASE

By entering the Contest, you agree to release and hold harmless, KPU, and its respective employees and agents from and against any losses, damages, rights, claim or cause of action of any kind arising, in whole or in part, directly or indirectly, out of your breach of the Official Rules, the use of your Entry in the manner set forth in these Official Rules, the use of the Prize or otherwise resulting from your participating in the Contest.

8. MISCELLANEOUS

KPU reserves the right, in its sole discretion, to cancel or modify the Contest if fraud, technical failures, or anyone's actions destroys the integrity of the Contest, or if factors beyond KPU's control make it impossible for KPU to administer this Contest as planned. Entrants who have not complied with these Official Rules are subject to disqualification. The Prize is not transferable and must be accepted as awarded with no substitutions in cash or otherwise, except at KPU's sole discretion. KPU reserves the right to substitute an alternate prize of equivalent or greater value if a Prize cannot be awarded as described. The Prize will only be awarded pursuant to the Prize Claim Conditions outlined above. By entering this Contest, you agree to be bound by these Official Rules and the decisions of KPU. All decisions of KPU are final and binding in all matters relating to this Contest.
